KEY CASE EXAMPLE *Tinker v Des Moines* 1969 THIS CASE ADDRESSED STUDENTS RIGHT TO WEAR ARMBANDS TO PROTEST THE VIETNAM WAR THE SUPREME COURT RULED THAT STUDENTS DONT SHED THEIR CONSTITUTIONAL RIGHTS AT THE SCHOOLHOUSE GATES APPLICATION THIS DEMONSTRATES THAT FREEDOM OF SPEECH IS NOT ABSOLUTE WHILE STUDENTS HAVE A RIGHT TO EXPRESS THEMSELVES THAT RIGHT IS NOT UNLIMITED AND CAN BE RESTRICTED IF IT SUBSTANTIALLY DISRUPTS THE LEARNING ENVIRONMENT INSERT A SMALL IMAGE HERE PERHAPS A SIMPLE ILLUSTRATION OF STUDENTS WEARING ARMBANDS OR A PHOTO OF THE SUPREME COURT BUILDING
